2. The following list of projects in the FY-1955 MCA Execution Program for Alaska has been released from the provisions of CCE multiple teletype, file ENOMW-2103, dated 16 December 1953 and has been approved by the Assistant Chief of Staff, G-4, for execution in FY-1954. Contracts may be awarded as soon as plans, specifications, construction directives, and funding become available and all required clearances have been obtained. Construction directives for projects that have not been authorized, will be issued by CCE when apportionment is approved by the Bureau of the Budget.
