



WHO IS BMC?


BMC Minerals Group was founded in 2014 through a partnership between its highly experienced management team and Barclays Natural Resource Investments. The company is focused on the development of base metals assets (primarily zinc, copper, and lead, which have strong mid/long term fundamentals). BMC's initial focus is on Western Canada, which has mining friendly governments, existing infrastructure, supportive geology and underdeveloped low-risk resources. BMC intends to add value by working within the local community to complete environmental studies, feasibility and permitting requirements and if economic, bringing mines into production, thereby providing long term value to both the company and the community. BMC management is experienced across a range of polymetallic sulphide deposits styles, including VMS deposits.

THE KUDZ ZE KAYAH PROJECT

BMC Minerals (No. I) Ltd (BMC) acquired the Kudz Ze Kayah property in January 2015 from Teck Resources (formerly Cominco). Kudz Ze Kayah (KZK) project is located approximately 260 km northwest of Watson Lake, I 10 km southeast of Ross River and 24 km south west of the Robert Campbell Highway near Finlayson Lake, Yukon.


The project is within the traditional territory of the Kaska Nation. The Kaska Nation in the Yukon is comprised of the Ross River Dena Council (RRDC) and the Liard First Nation (LFN).

Access to the project is via a 24 km long, all weather, single lane gravel tote road that connects the KZK project to the Robert Campbell Highway. A seasonally staffed gatehouse exists at the tote road entrance.



Kudz Ze Kayah Project Location


Kudz Ze Kayah is a prefeasibility study zinc-copper-gold-silver-lead development asset with a resource upside (it is a VMS-type deposit). In the 1990's Cominco completed significant geological, geophysical, metallurgical, and environmental programs on the KZK property. The programs included drilling nearly 200 diamond drill holes to define the extents of the massive sulfide body (the ABM deposit). Concurrent with this work, step-wise exploration across the property resulted in a second discovery of the GP4F deposit located 5 km southeast of the ABM. Very little work on the KZK property has been completed over the last 16 years.

BMC plans to: complete the required environmental and socio-economic studies; obtain the required permits; drill development targets; and complete a bankable feasibility study for the project. If feasible, BMC will work towards an operating mine.

EXPLORATION PROGRAM (EQUITY) EXCE



BMC has applied for an exploration permit for the Kudz Ze Kayah project. Exploration activities are expected to commence within one month of the permits being granted. The exact date of grant currently unknown but is anticipated to be early summer 2015. The purpose of the exploration program is to advance the KZK project by continuing the work started by Cominco. The ultimate purpose is to demonstrate economic viability of the project.

Planned exploration work for the 2015 season will primarily be diamond drilling and airborne geophysical surveys. Diamond drilling will comprise approximately 30,000 m from 100 sites, with 20,000 m designated for the ABM deposit and the remaining 10,000 m allocated to other targets, including the GP4F deposit.

ENVIRONMENTAL PROGRAM

The Kudz Ze Kayah project occurs within the Pelly River and Pelly Mountain ecoregions. It is located within the northern foothills of the Pelly Mountains of the Yukon Plateau, on the east side of the divide between the Pelly River and the Liard River drainage basin. The topography of the area consists of rolling hills, locally with ponds and lakes occupying valley bottoms.

Baseline environmental and socio-economic studies and an environmental impact assessment were undertaken for the project in 1994/1995. BMC has initiated the full suite of studies for 2015/2015 (including, but not limited to: wildlife, vegetation, soils, fish and aquatics, surface water quality and quantity, groundwater quality and quantity, and socio-economics). BMC is currently working with the

RRDC on Traditional Knowledge protocol and we hope to start the traditional use study in 2015.

In March 2015 a late winter ungulate survey was conducted for the entire Game Management Unit surrounding Kudz Ze Kayah to document the late winter distribution of caribou and moose relative to the proposed Kudz Ze Kayah mine project. 31 moose and 19 caribou were observed within the survey area. All ungulate observations were recorded north of the Kudze Kayah project area. Two wolf packs (6 and 7 wolves/pack) were also observed within the survey area.

KUDZ ZE KAYAH PROJECT UPDATE

The scoping study is currently underway and will be completed in the next couple of months and the prefeasibility study will be completed in March of 2016.

EXPLORATION PROGRAM

The exploration program underwent a Designated Office –level Yukon Environmental and Socioeconomic Assessment Board review in early 2015 and a Mining Land Use Approval (Class 3) LQ00424 was issued in late June 2015.

Through July the exploration camp was constructed and the drill rigs and exploration team mobilized to site. There are currently 4 drill rigs at the site. The current drilling is focused on exploration at the ABM deposit and the hydrogeology program.

To date we have had Aurora Geosciences conducting the ground based gravity survey. Geotech conduting the drilling and Challenger conducting the surveys at the site. We are proud to have hired local crew members to date approximately 30 percent of our staff are local Yukoners and/or RRDC members.





EXPLORATION PROGRAM

In spite of the approaching cold Yukon weather and shortened daylight hours, it is still very much "field season" at the KZK Project. September and October were highly productive months with four drill rigs consistently turning out stacks of drill core that kept our core shack team on their toes. Currently three drill rigs are still working to test the edges of the ABM Deposit as well as some nearby conceptual exploration targets. Geophysical, metallurgical and hydrogeological programs were completed in October and a sampling program focused on waste rock characterization is on-going.

HEALTH SAFETY AND ENVIRONMENT

The KZK Safety, Health, and Environmental Management Plan (SHEMP) is an occupational Health and Safety management system implemented to incorporate BMC's guiding policies, management plans and Equity Exploration Consultants' operational policies and procedures that provide guidance and reference material to personnel at the KZK project. The key aspects of the plan were developed into SHEMP cards.

Our staff and contractors participated in the program by filling out the SHEMP cards to inform BMC of Health Safety and Environmental items that needed attention or for compliance records with our exploration permit. - Fish and aquatics baseline report is being prepared.
- Monthly environmental baseline monitoring will continue through the winter of 2015/2016.









EXPLORATION PROGRAM

BMC's 2015 field season was officially completed in early December, with the geotechnical program wrapping up and final crews leaving the site on December 11. The 2015 exploration program at KZK was considered a success having achieved all of our objectives and in some cases surpassing our expectations. We have spent the past couple of months reviewing the data, updating our resource estimates and are currently planning our program for this year. The field work is planned to start in early May and to be finished by the end of October. The five-year exploration approval granted last year will allow for an earlier start to the fieldwork this year.

We are proud to have lived up to the commitments we made to Yukon communities when we began our project and we look forward to our future work in Yukon, working with Yukoners.



EXPLORATION PROGRAM

BMC opened the camp in early April and soon after two skid mounted rigs were mobilized to site. The focus of the drilling to date has been infill drilling at the ABM deposit. Since early April our camp has been at about 50 percent capacity (i.e. 25 people). In mid-June another rig will be on site and at the beginning of July the fourth rig will arrive and our camp will be full (49 people) for the remainder of the season. This year we plan to drill approximately 20,000 meters at KZK.

BMC'S NEWEST TEAM MEMBERS

Rob McIntyre, R.E.T, Senior Advisor

Rob is a Yukoner having lived and worked in Yukon for more than 35 years. He has considerable experience in permitting mining projects and in First Nations engagement. As BMC's Senior Advisor, Rob is currently working with BMC on: negotiations of the Exploration Memorandum of Understanding with RRDC, implementation of the existing Socio Economic Participation Agreement with RRDC, assisting with our successful interaction with the community; and developing BMC's strategies for permitting the Kudz Ze Kayah project.



Kathlene Suza, Mentor/Liaison

Kathlene is a RRDC citizen with extensive experience working with RRDC, Kaska Tribal Council, and mining companies. Her various positions have included mining liaison, nursing, and counselling. Kathlene's unique experience will be an asset to BMC as we strive to retain our local employment base. Kathlene's main role will be to ease the transition of employees new to the workforce or new to mining to adjust so that the opportunity for continued employment and advancement is maximized.



ENVIRONMENTAL PROGRAM

BMC has completed its first year of environmental baseline studies at Kudz Ze Kayah. The data collected in 2015 has been incorporated with the data sets from the 1990's. Currently the 2016 baseline program is underway, the results of which will also be added to our extensive existing dataset, in early 2017.



CULTURAL AWARNESS TRAINING



In February two Ross River Dena Council Elders provided cultural awareness training to the BMC and Equity Exploration management teams. We sincerely appreciated learning about RRDC history and culture. In follow-up BMC is planning a cultural awareness field program at KZK during the 2016 exploration field season.

COMMUNITY EVENTS

In early June BMC was invited to Ross River to give a Kudz Ze Kayah project update presentation to the Ross River Dena Council Elders Committee. The meeting was well attended. Given the history of the project, many of the attendees were already familiar with Kudz Ze Kayah. BMC would like to thank the RRDC elders for their questions and feedback provided during the meeting.

The elders spent the afternoon discussing the cultural values of the Kudz Ze Kayah area and we are looking forward to receiving this information, so that we can incorporate it into project planning and development of mitigation measures.

ENVIRONMENTAL PROGRAM

They assisted the site environmental manager in implementing the KZK environmental management plan and assisted our consultants with collecting the environmental baseline data. Our site environmental manager mentored both Jody and Terry throughout the field season.

BMC's environmental baseline studies program will continue through the winter with surface water and groundwater sampling, snow surveys and winter wild-life monitoring.
