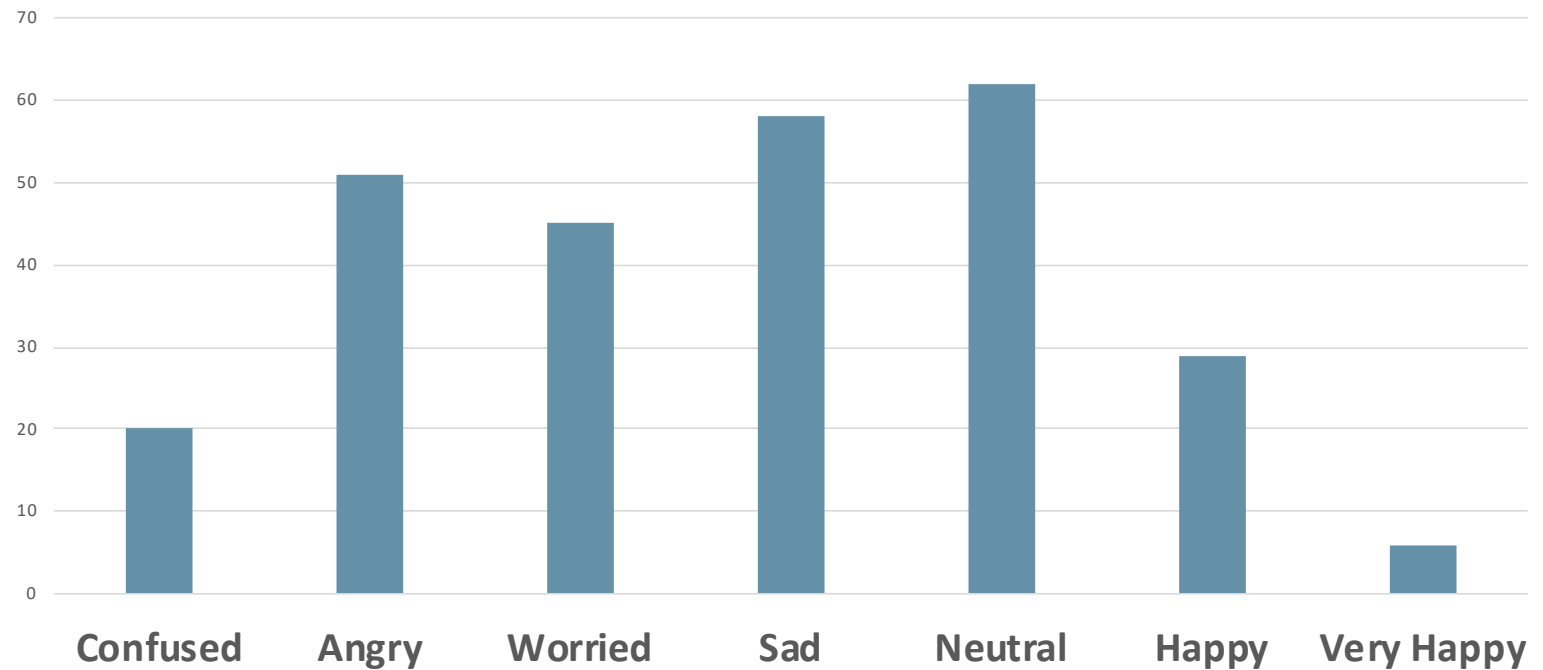

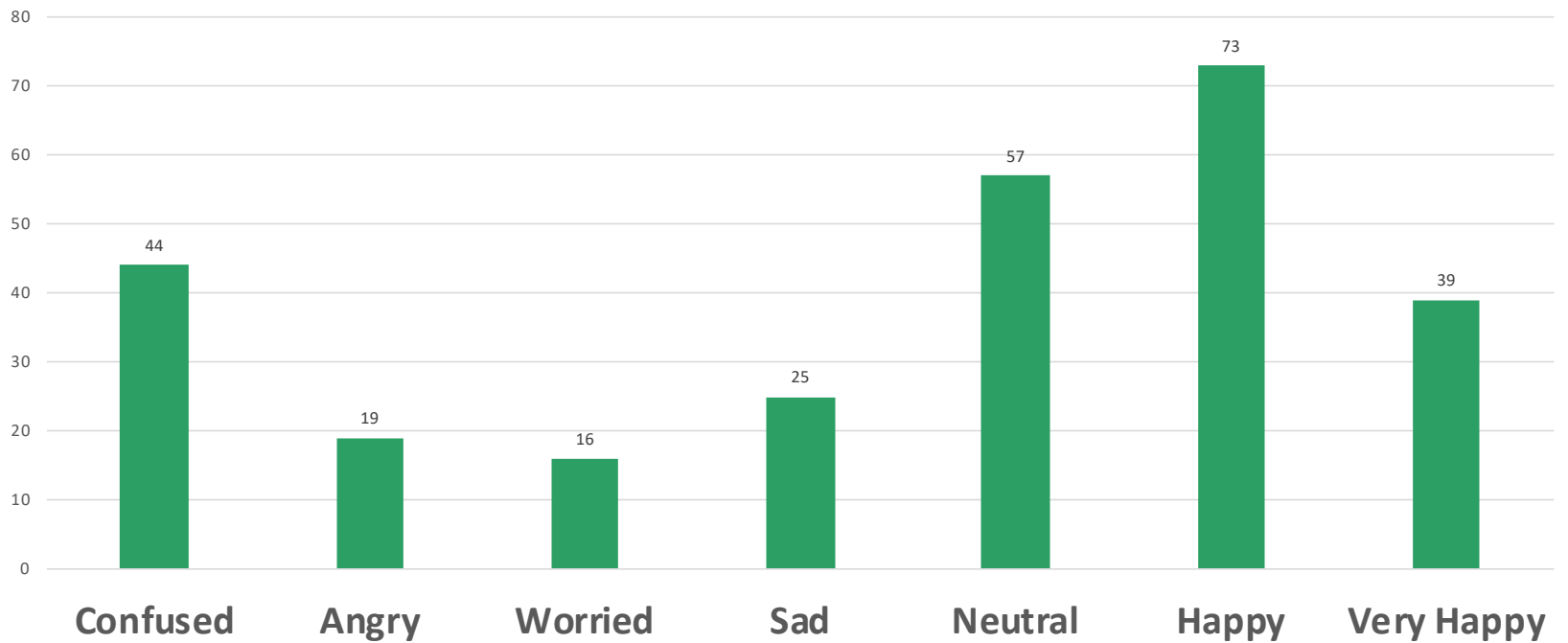
How do you feel about the current state of mineral development in the Yukon? (n=230)

How do you feel about the Panel's mandate?

Very Happy/Happy: Glad it's being done. Seen as necessary.

Angry: Positional in nature, for or against elements of the mandate

Confused: Unclear about the mandate, the motivations behind it, or how it will be achieved

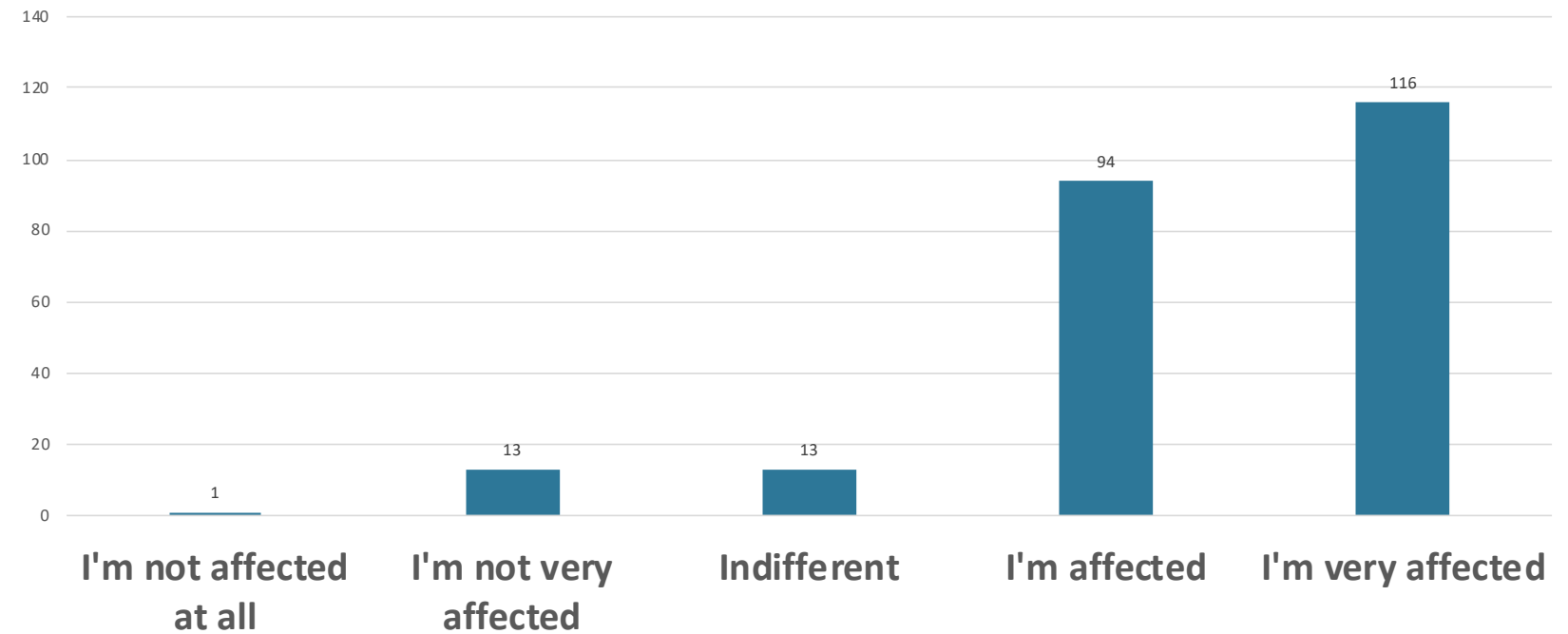
Sad: People not seeing themselves represented in the mandate (gender, non-FN people)

Worried: Fear of loss. Fear of bias.

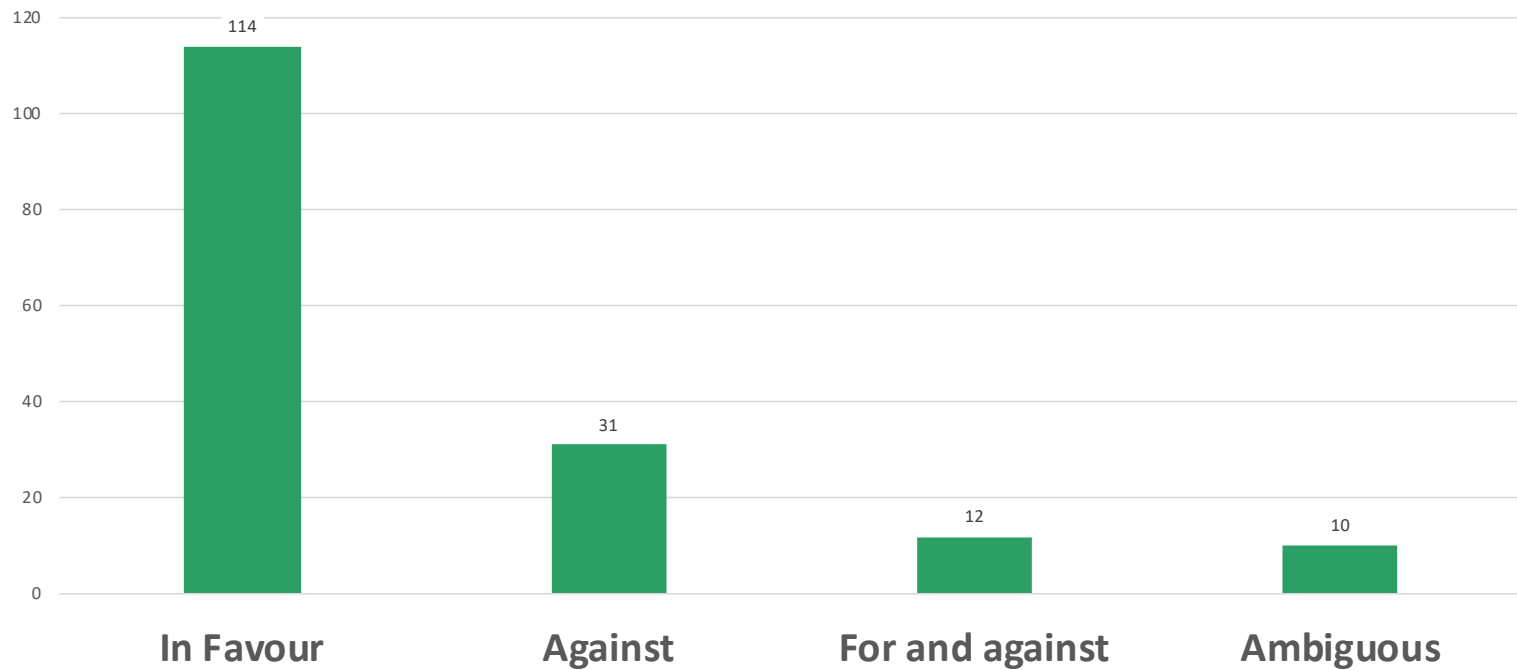
How affected are you by mineral development? (n=237)

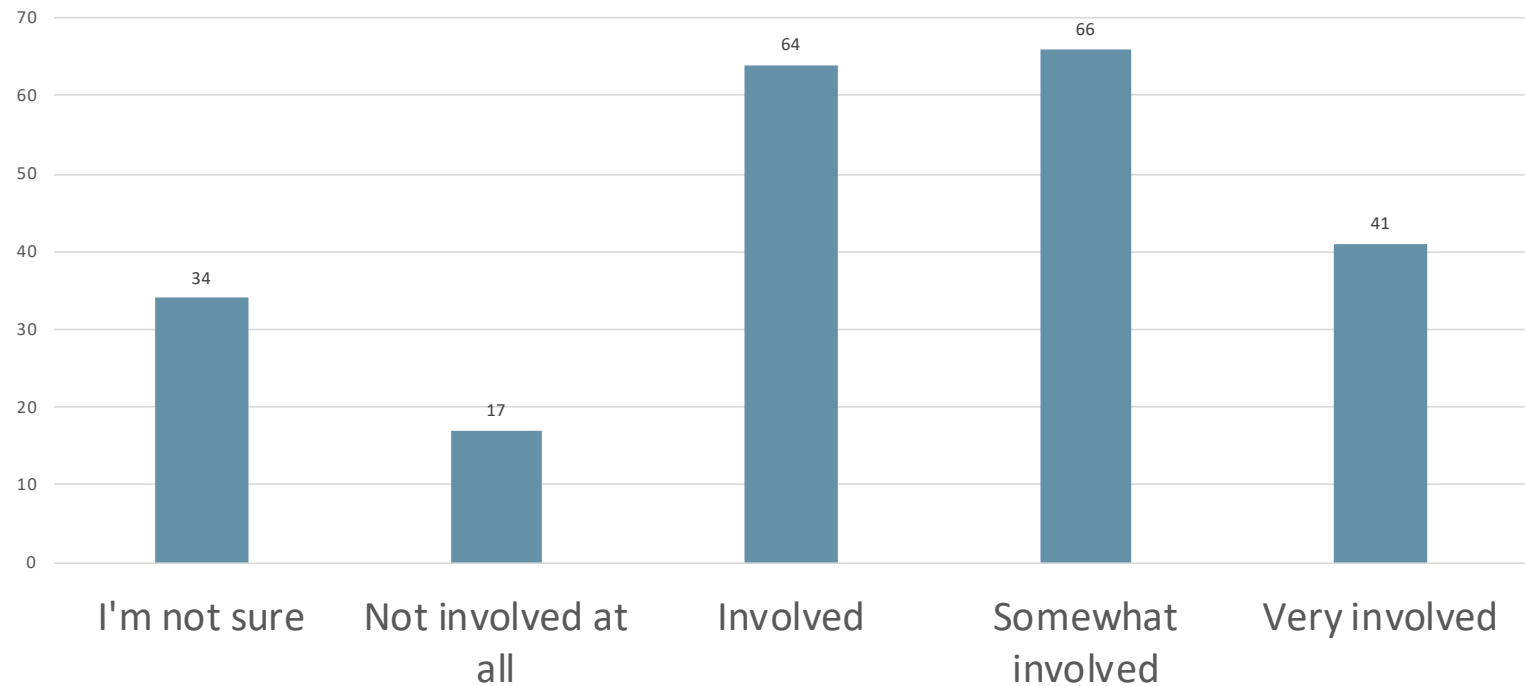
Why are you affected?

- Be accessible
- Promote the process
- Engage the right audiences
- Educate people (about all kinds of things)
- Use a variety of engagement methods
- Mandate (too broad/do it)
- Panel (be independent, diversify)

What advice would you give the Panel? (Themes)

- Process (General recommendations on how the process is designed)
- Consider a wide range of subjects from a variety of perspectives
- Take the time to get it right/to let people engage
- Consider how input is weighted
- Be transparent
- Product (Think long-term, with recommendations that are strong, clear, progressive, and that make a difference)

What questions should the Panel ask?

- What do we want from mineral development? (What is the vision?)
- How do we ensure Yukoners/First Nations benefit, and what benefits?
- How do we manage land access and competing interests (including land use planning)?

- How do we find the right balance (between the economy and the environment)?
- How do we find the right balance (between mineral development and social impacts and benefits)?
- How do we consider the environment (climate change, cumulative effects, sustainability)?

What questions should the Panel ask?

- How do we ensure Yukoners and the environment are protected when mineral development activity ceases?
- How can the regulatory process be both effective and efficient?
- What should new legislation look like?
