Introduction

The aim of this study is to identify and prepare information on the key experts and stakeholders in Canada that can assist the NRTEE with its climate change initiative

The information is organized around three broad categories relating to climate change. They are: Causes; Impacts/Adaptations; and Responses. The focus of this report is foremost on impact and to a lesser degree on the responses.

By selecting only 30 key Canadian experts & 30 key Canadian stakeholders we will not satisfy everyone that the choice of these 60 represents the top people. However, within the financial bounds of the contract, a choice has to be made as a point of departure. During the course of the study, many other names and contacts will be identified and the CGCP will be pleased to revisit these once the current task has been completed and the final report delivered.

The final report will be organized around four sections:

- 1- Methodology
- 2- List of Canadian experts organized by sectoral areas of expertise
- 3- List of Canadian stakeholders organized by type of organization
- 4- Annex with a more complete record for each of the selected 30 experts and 30 stakeholders [See Annex of this interim report for the type of information to be collected]

Methodology

In order to organize the work and to ensure coverage of the major sectors involved in global climate change we have used modified versions of the categories defined by the IPCC and the Canada Country Study to classify the experts. They appear in the box.

Experts were then selected and matched to different sectors and categories. Phone interviews, which are ongoing, have been conducted to validate our identification of key experts. These interviews often generated new experts and stakeholders. Preliminary lists are presented as Annex x & y. It should be understood that these lists are purely indicative at the moment since new information is being collated daily.

Selection for the final report will be made by CGCP advisors, keeping in mind the objective of selecting experts and stakeholders that strive to be national in their influence or expertise and that are focused more on the impact and response sides of the issues.
